# EFFECT OF NEW MAIL DELIVERY POLICIES IN PRINCE EDWARD ISLAND

**Mr. George Henderson (Egmont):** Mr. Speaker, the policies of Canada Post are becoming more ridiculous by the day. For instance, in Summerside, Prince Edward Island, only one home owner, the Simpson family at 380 Brophy Avenue, does not receive door-to-door mail delivery. Yet each day a letter carrier walks by and delivers mail to a nearby apartment building. On April 14 I wrote to the Minister responsible for Canada Post but all I received in response was a form letter. He did not even bother to investigate.

Canadians from coast to coast are fed up with the policies of the Conservative Government which are forcing Canada Post to cut back postal services to our taxpaying citizens. I quote from a resolution passed at the annual meeting of the Federation of Prince Edward Island Municipalities:

The new delivery policies are discriminatory as new subdivisions will not receive the same benefits as an already established subdivision.

I urge the Minister to review the Simpson case and give that family what they deserve, good postal service.

# CRITICISM OF PROPOSED NEW LEGISLATION

Mr. Bill Blaikie (Winnipeg—Birds Hill): Mr. Speaker, last Friday the Minister of the Environment (Mr. McMillan) introduced the new Canadian Environment Protection Act. I would like today to express my concern that some of the headlines concerning the Bill may cause Canadians to take too much comfort in the actions of the Minister. I see headlines such as: "Tough New Environment Act". The fact is that except for the emphasis on fines, if we take a good look at the Bill we see it is not a very tough Bill after all.

When we look at the fact that there is so much ministerial discretion involved, so much devolution of powers to the provinces with respect to how the Act will be enforced and administered, when we consider the persistent exclusion of important areas of concern such as pesticides and radioactive substances, when we consider the failure to include an environmental Bill of Rights or to give individual Canadians a standing in the courts with respect to environmental concerns, when we consider all those things it becomes clear that the Canadian Environmental protection Act is not the comprehensive piece of environmental protection legislation the Minister of the Environment has been promising.

Therefore, I ask Canadians who are concerned about the environment to look at the fine print and not take too much comfort from what has happened so far.
