WATER PATROL UNITS

Mr. Russell MacLellan (Cape Breton—The Sydneys): Mr. Speaker, my question is directed to the Deputy Prime Minister. The RCMP has cancelled its' water patrol units. The water patrol units of the RCMP have been responsible for patrolling and for matters relating to the Shipping Act and the Migratory Birds Convention Act. It is the only agency patrolling for water safety and has been responsible for uncovering a great deal of illegal drugs coming into Canada, a racket which now amounts to \$10 billion a year. In light of the good work these units have done, why has the Government disbanded them?

Mr. Murray Cardiff (Parliamentary Secretary to Solicitor General of Canada): Mr. Speaker, I thank the Hon. Member for the question and for bringing to the attention of the House the good work of these units. I would like to take notice of the question and have the Solicitor General respond to it when he returns.

INTERIM SALES TAX CHANGES

There were press reports earlier this week indicating that he may be shelving the interim sales tax measure that was announced last February. Such a move, of course, would create a cloud of uncertainty for tax professionals and business people. What are the Minister's intentions in this regard?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, over the course of the few months since we did release those proposals on the interim sales tax changes, we have had considerable consultations and discussions with members of the private sector, tax professionals and others who do have an interest in this particular issue. On the basis of these consultations, we are proposing to make some technical changes which will make the proposals more workable. I would expect to be introducing legislation into the House, based on these technical revisions that I have referred to, some time in the next little while.
