POST OFFICE

PROPOSED INQUIRY INTO OPERATIONS—MOTION UNDER S.O. 43

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, I rise on a matter of urgent and pressing necessity under the provisions of Standing Order 43. In light of the continued deterioration in the service offered by Canada's post office as documented by press articles and the increasing flow of letters of protest from constituents to members of parliament, a situation further aggravated by the current breakdown in contract negotiations over a matter that would have been insignificant if the post office management had introduced modern industrial relations practices into the post office department at the time when the decision was made to move rapidly into mechanization and automation, I move, seconded by the hon. member for Esquimalt-Saanich (Mr. Munro):

That the government immediately set up a joint parliamentary committee similar to the committee that studied the 250 recommendations for improvement in employer-employee relations in the Public Service, a situation that has been further exacerbated by the government's failure to act on the Finkelman committee report, to examine in depth the Canada post office and to recommend solutions for the current crisis which has resulted in deteriorating service, a breakdown in labour management relations with the CUPW and the problems with mechanization and automation in the Toronto area that have been playing havoc with mail service throughout Metro Toronto and across Canada.

PROPOSAL THAT COMMITTEE STUDY EXTENT OF MATERIAL DIRECTED AT CHILDREN—MOTION UNDER S.O. 43
