THE FAIRLY ASSESSMENT MATTER.

Coun. Cameron read the following Committee report: "Your Committee to whom was referred the matter in connection with over-assessment of Mrs. Sarah A. Farley, of Ludlow, beg to report as follows, viz.—We find that she has been over-assessed on personal property to the amount of \$4,000, making her taxes \$13.00 too high, and recommend that the collector for the Parish of Ludlow be ordered to pay over that amount to her out of rates collected in that Parish for the present year. ALMHOUSE.

Coun. Saunders read report of Committee appointed to visit Almhouse and report thereon to which the Committee stated that they had found everything in that institution clean and in good condition and recommended that this Council ask the Almhouse Commissioners to grant Miss Ann Harrington the sum of \$60 per annum as assistant keeper, as they did not consider the keeper was sufficiently remunerated for the amount of work he had to perform. They also recommended the building of a fine cess-pipe to be placed on the premises.

NORTHERN AND SOUTHERN ASSESSMENT.

Coun. Toser then moved the following resolution: "Resolved, that the Parish of North Ek be divided into two parishes, viz. North Ek and South Ek, up to 1882, on the basis of the assessments made between the two said parishes as inrolled, as shown by a report of a committee of five members of this Council appointed in January session of 1882. Therefore resolved that five members of this Council be appointed a committee to inquire into this matter and report at this meeting of Council. Carried."

COUNTY ACCOUNTS.

Coun. Adams, chairman of the committee on County accounts read the following report: "The committee on County Accounts beg to report as follows: We find the accounts fairly satisfactory but regret to notice that many articles have been got for the gaol without the privilege, consent, or order of the gaoler, and would call their attention to a standing resolution of Council ordering accounts to be accompanied with such order, and would further recommend that they exercise greater care in the future in this respect, which will swell the account considerably. The fuel account is large, but we find the wood has just been delivered out of course, for future use. We find the account for horse hire to convey prisoners to be entirely out of order, and it should not be paid unless embodied in the Constable's account showing the cause why it should be. We beg to call your attention to the accounts expended in holding Coroners' inquests and we hope some action will soon be taken by the local Government to remedy the evil. We also find the law in reference to Coroners' summoning juries to be very loose, as it allows them from \$0.50 to \$20.00, and we find much difficulty in doing justice between those who charge the extreme amount and those who charge the moderate amount. We request very much to notice so many charges for certificates of lancy and cost of conveying to lunatic asylum, and would recommend that no such charges be paid when the parties are known to possess property. We also find a bill presented for taking care of a crazy sawy correct, but have referred it to the Indian Commissioner, as we believe it should be paid by the Indian fund. We find the Secy-Treas. account correct, showing a balance on hand of \$1,827.70. Signed, A. ADAMS, Committee. G. F. FOWLER, Chairman."

NEWCASTLE FIRE MATTERS.

Coun. Morrison's motion in regard to the request of the Newcastle Firewards having been again brought before the meeting, Coun. Adams moved, seconded by Coun. Ryan, an amendment to Coun. Fish's resolution that a committee of three be appointed to wait upon the fireward and see if another piece of land would not suit as well. Coun. Adams thought that the public slip, of which they wanted a part, might be needed at some future day for other public purposes—perhaps for a site for a Market House. After some discussion by Coun. Fish, Morrison, Ryan, Adams and others, Coun. Adams asked the Secy-Treas. if the Council had power to deal with the land in this way. The Secy-Treas. said that it had been laid out as a public slip and until it was closed up the Council had no power to grant it or any part of such land, unless by permission of the Council by which it was given, it would be of no effect. The Wardens then declared the resolution was of no effect. CHATHAM PUBLIC SQUARE. Coun. Loggie, seconded by Coun. Flanagan moved that this Council grant the sum of one hundred dollars out of the County funds for the purpose of improving the Chatham Public Square. Coun. Fish thought they ought to employ in that resolution the same amount for the Newcastle square. The resolution, on being put, was lost. Coun. Flanagan, Flanagan, Fitzpatrick, Loggie, Morrison, Fish, Savoy, McLaughlin—9. Coun. Adams, Bamford, Freese, Dunlop, Jardine, Adams, Ryan, Thibodeau, Currier, Saunders, McNaughton, Foley, Sullivan—14. Coun. Bamford asked for leave of absence this afternoon which on motion was granted. On motion the Council adjourned till 3.30 o'clock for committee work, at which hour the meeting having been called to order by the Wardens.

NEWCASTLE POLICE MATTER.

On motion the passing of County acts was deferred to allow John Niven, Esq., Police Magistrate of Newcastle, to give an explanation of his return. Mr. Niven's attention having been called to the fact that his return had been objected to by Coun. Morrison, who said that he knew of five parties whose fines had been paid, but by the magistrates return it would appear that they had not been and that the parties had been sent to gaol, explained that he had made a mistake in reference to one but could not say as to the other four, whether he or the gaoler had made a mistake. If the gaoler had discharged from him he (Mr. Niven) would account for the fines and if the gaoler had not got discharges he should not have released the prisoners. He could not give a fuller explanation till he saw Mr. Forrest who was gaoler at that time. Moved and seconded that Mr. Forrest be telegraphed to Chatham for to be present at the meeting of Council this evening at 8 o'clock or near Samuel Brown's.
