In consideration of WINGS LIMITED (hereinafter called the "Company") permitting me, at my request and at my own risk against all casualties, to travel by aircraft operated by the Company between the points indicated on this ticket, or for part of such distance, I HEREBY AGREE with the Company that such journey is taken at my own risk against all casualties to myself and/or my property, and that I accept all risks of every kind and nature whatsoever, no matter how caused, and I hereby release, release and discharge absolutely the Company, its successors and assigns, of and from all actions, causes of action, suits, claims and demands whatsoever, that I may hereinafter or hereafter claim, or any other person, now or hereafter claim, shall or may have against the Company, its successors or assigns, for, on account or by reason of my death or any loss, damage or injury to me and/or to my property, while so travelling, or while in, on or about any such aircraft, or while going to or from or onto or off, or embarking upon or disembarking from the same, or in any manner whatsoever, or by reason of the failure of the Company's aircraft to depart from or arrive at any point according to any schedule, agreement or otherwise, or at all, or by reason of any delay in the said journey howsoever caused; and, without restricting the generality of the foregoing, whether or not such action, cause of action, suit, claim and demand, may arise by reason of the neglect, wrongful act, or omission, default, delay or misconduct of the Company, its servants or agents, or by reason of defective aircraft, equipment, buildings, premises, materials, ways, works, machinery, plant, workmanship or construction, or any defect in the condition of arrangement of the same or by reason of a dangerous condition thereof or otherwise howsoever.

And I agree with the Company that it may cancel at any time the entire flight, or any portion thereof, and shall be under no obligation with respect to such cancellation, except to refund the part of the fare paid proportionate to the uncompleted portion of the journey for which this ticket is issued.
