Any event which increases the happiness of our beloved Sovereign, cannot but be pleasing to Her loyal subjects; and the recent addition to the Royal Family affords us sincere gratification.

For a plentiful Harvest and an abundant Fishery, we are grateful to the bountiful Giver

of all good.

Although our Revenue be for the present somewhat deficient, yet we trust the cause is of a temporary nature, and we shall endeavour by carefully and judiciously husbanding our resources to render them adequate to the public service.

Your Excellency's approbation of the prudence of the Legislature in making provision for casualties, gives us pleasure, and we doubt not that the fund placed at your disposal

has been wisely expended.

To vindicate the Royal Prerogative, and to extend equal justice to all without reference

to party, are the paramount duties of the Queen's Representative.

For Your Excellency therefore to rely upon the advice of those who represent the feelings and interests of a portion only of the Queen's subjects, would be a dereliction from

those duties, and lead to injustice and oppression.

Cordially concurring in Your Excellency's sentiments on this momentous subject, and regarding the past as an auspicious presage of the future, we venture to assure you that by a continuance in the course hitherto pursued by Your Excellency, you will secure for yourself the affectionate regard of every loyal subject, and confirm the devoted attachment to our Gracious Queen, and our happy connexion with the Mother Country which now animates the Inhabitants of this favoured portion of the Empire.
