PROCEEDINGS AT THE HAGUE.

Italian and American Amendments to the Hague Arbitration Scheme.

The Hague, May 30.—The drafting committee, or sub-committee of the arbitration committee, met yesterday and discussed the Russian scheme, adopting with slight modifications, the first six articles. Count Nigra, chief of the Italian delegation, submitted a proposal of mediation and arbitration, consisting of six articles, in the form of an amendment to the Russian project.

The Americans also submitted an amendment, demanding that in the event of a dispute between two nations, each should choose another nation to act as arbitrator, and that the arbitrator should be chosen by the two nations, which the Americans will introduce during the week.
