Canada? Before permission is given to give up this franchise will the minister investigate these conditions a little further?

Mr. McIlraith: Mr. Speaker, it is not the minister who does the investigating. I am quite familiar with the facts relating to the operation, nevertheless the allegation made by the hon. member is something that should be brought before the air transport board at its hearing, where it could be dealt with by the board.

INCOME TAX

QUEBEC-INQUIRY INTO RECEIPTS FOR CHARITABLE DONATIONS

Mr. Marcel Lessard (Lake St. John): Mr. Speaker, I should like to direct a question to the Minister of National Revenue.

Could the minister inform the house if his department has given instructions to reduce the amounts claimed for charitable donations, as is being done in the province of Quebec, without first making an investigation to ascertain whether or not the receipts are genuine? [Text]

Hon. J. R. Garland (Minister of National Revenue): The answer, Mr. Speaker, is no.

Mr. Garland: The hon. gentleman is now slipping in quite a different question from the one asked by his colleague, and under the circumstances I ask that he put his question on the order paper.

NORTH PACIFIC COMMISSION—INQUIRY AS TO MEETING OF ADVISORY COMMITTEE

Can the minister indicate to the house when arrangements are going to be made for this advisory committee to be consulted before negotiations are reactivated among Japan, the United States and Canada for the signing of a new treaty involving the three fishery stocks in the north Pacific?

Mr. Robichaud: At the meeting that will be held in Vancouver this November.

NORTHERN AFFAIRS

ALASKA HIGHWAY—INQUIRY AS TO NEGOTIA-TIONS WITH UNITED STATES

Mr. Erik Nielsen (Yukon): I wonder if the minister of northern affairs could take the house into his confidence and inform us just at what stage negotiations are now between this government and the government of the United States, as well as British Columbia, in respect of the cost sharing arrangement for the paving of the Alaska highway.

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): When the arrangements are completed, as we hope they will be successfully, an announcement will be made.

Mr. Nielsen: May I ask a supplementary question. Can the minister say, then, that we are to take it from his answer that there are negotiations being conducted on the cost sharing of the paving of the Alaska highway between these governments and the Canadian government?

Mr. Laing: There would be no profit in discussing that today.

Mr. Nielsen: I have a further supplementary question in respect of the one I asked of the minister of northern affairs concerning negotiations with the United States government. In view of the fact that the minister has taken into his confidence the president of the Dawson Creek chamber of commerce, and has told that chamber of these negotiations, will he now take the house into his confidence by telling the members of this house whether or not these negotiations for cost sharing are taking place?
