REGULATIONS RESPECTING KILLING OF SEALS

this question to the Prime Minister. It arises out of an article which appeared in the Toronto Globe and Mail entitled "Baby seal killing", and so forth. The article deals with a full page story in the German newspaper Weekend circulated in many countries, entitled "This scandal should shock the world". The article suggests that the killing of seals is so cruel and inhumane that action should be taken and that, among other things, letters should be directed to the Prime Minister and to myself in this connection.

I should like to ask the Prime Minister whether he has not received almost an avalanche of letters on this question; and whether under the circumstances, in view of the statement as far back as May last, in answer to questions by myself and other members, that amendments would be made to the law to put an end to this practice which, as described, is dastardly cruel. Among the matters that will be introduced before this session ends will there be legislation to bring about an end to this practice and to improve Canada's image, which cannot but be seriously damaged in this regard.

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, I have not seen the article in question in the German Weekend magazine, though I will take steps to get a copy of it. My right hon. friend knows that the Minister of Fisheries made a statement in the house, I think it was last week, in which he indicated that action was going to be taken in respect of this matter and that he would make a report to the house shortly in regard to that action. I will be glad to look into the matter along the lines suggested by my right hon. friend.

Mr. Diefenbaker: Mr. Speaker, may I then ask the Minister of Fisheries, now that four or five months have passed since he undertook, in answer to the hon. member for Ontario, to bring in legislation, whether this legislation will be introduced so that this practice which seriously defaces Canada's image will at least be subject to punishment.
