*STUDENTS SENT TO U.S. SCHOOL BY CANADIAN S.I.U.

RESTRICTED SERVICES TO APARTMENT BUILDINGS, OTTAWA

Question No. 2,087—Mr. Howe (Hamilton South):

1. Has the government received representations or information to the effect that in several apartment buildings in Ottawa (a) only one dairy, one bakery, and one cleaning firm are permitted to enter to conduct business (b) that most of such firms provide to the building landlord, owner, or superintendent a kickback in the form of cash, free service, service at a discount, or a portion of profits and (c) that in some cases compulsion to use the services of specified firms has been written into the lease, and that failure to use these services can result in eviction?

2. Has the restrictive trade practices commission undertaken any investigation of this matter and, if so, what are the names of the firms and apartments under investigation?

3. If no investigation has been initiated, is one being considered?
