As of September 30, 1967, 85 Indians have been approved for assistance under the "off-reserve housing program". Statistics are not available on the choice of house the Indian has or will select. All houses selected must have Central Mortgage and Housing approval. Indians qualifying for off reserve assistance are located as follows: Maritime region, 4; Quebec region, 2; Ontario region, 14; Manitoba region, 21; Saskatchewan region, 13; Alberta region, 4; B.C. and Yukon region, 27.

# CANADIAN PAVILION AT EXPO

# Question No. 492-Mr. Forrestall:

1. What is to become of the Canadian pavilion at "Expo 67" after the exhibition closes?

2. Specifically, what plans does the government have for Katimavik?

Hon. Robert Winters (Minister of Trade and Commerce): 1 and 2. Negotiations, which are taking place between the city of Montreal and the government of Canada for the disposition of the Canadian pavilion, including Katimavik, have not yet been concluded.

# ROLLED STEEL IMPORTS

#### Question No. 496-Mr. McCleave:

1. What was the total value of rolled steel imported into Canada in 1966, from what countries was it imported and in what dollar volume in each case?

2. What was the amount of rolled steel imported into each province of Canada in 1966, by dollar volume?

Mr. Jean-Charles Cantin (Parliamentary Secretary to Minister of Trade and Commerce): 1. The total value of rolled steel imported into Canada in 1966 was \$207,000,000 of which \$48,402,000 was material of a class or kind not made in Canada, and \$29,000,000 represented importation in rolled form of ingots sent to the United States for purposes of conversion.

Details by country and dollar value for each of the countries for the 55 classes of rolled steel imported into Canada in 1966 may be found on pages 128 to 134 (commodity classes 444-05 to 447-99) of the December 1966 issue of the Dominion Bureau of Statistics publication, "Imports by Commodities", catalogue number 65-007, which is available in any public library or the library of parliament.

2. The amount of rolled steel imported into each province of Canada in 1966, by dollar volume is as follows:—
