CANADIAN SOVEREIGNTY

ALLEGED REFUSAL BY INTERNATIONAL TELEPHONE AND TELEGRAPH CORPORATION TO PERMIT VISIT TO RESOLUTION ISLAND BY NORTHWEST TERRITORIES COUNCILLOR—CANADIAN POLICY

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, I direct my question to the Secretary of State for External Affairs and it arises out of the question asked earlier by the hon. member for Spadina. Are there today in the Arctic Islands of our country areas in regard to which the decision whether a Canadian shall enter is determined by military regulations of the United States, and that no one can go on those islands without the consent of the International Telephone and Telegraph Corporation of New Jersey? I ask this question because, if such is the fact, it constitutes a flagrant invasion of the rights of Canadians.

- Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the Minister of National Defence is looking into the facts which may or may not be as represented in this newspaper article. I think that until we know what the facts really are it would be imprudent to answer the question.
- Mr. Diefenbaker: Mr. Speaker, I am trying to find out what is the basis for the facts. Has the government of Canada under an exchange of notes granted certain rights whereby portions of our northern areas are subject to United States military law and Canadians are denied their right to be in the areas in question? I repeat has there been any such arrangement made with the United States?
- Mr. Sharp: Mr. Speaker, I would doubt that there are any arrangements of such a kind in effect except those relating to security. These would affect not only Canadians but anybody else who wanted to enter upon property where matters are secret in the interest of the security of Canada. I am sure the right hon. gentleman would agree that this would be quite appropriate.
- Mr. Diefenbaker: Mr. Speaker, I have asked a simple question. The Secretary of State for External Affairs says that there may be or there may not be such arrangements. During his administration, or that of his predecessor, has the government of Canada agreed that a United States corporation shall determine Canadians' rights to be in the north? Do not excuse it by reason of security.
