HOUSING

REQUEST FOR INCREASE IN AMOUNT OF LOAN UNDER AHOP AND REDUCTION IN MORTGAGE INTEREST RATE

Mr. John Gilbert (Broadview): Mr. Speaker, my question is directed to the Minister of State for Urban Affairs. In view of the fact that the price of homes has moved beyond the reach of most families, would the Minister of State for Urban Affairs increase by at least 50 per cent the direct lending allowance of CMHC for AHOP non-profit and public housing to at least provide housing for people of low or moderate income at a reasonable price?

Hon. Barney Danson (Minister of State for Urban Affairs): Mr. Speaker, I will consider any suggestion the hon. member makes.

Mr. Gilbert: A supplementary question, Mr. Speaker. In view of the fact that the Minister of State for Urban Affairs and his officials have been in touch with the financial institutions concerning the recent increase in mortgage rates by the banks, has the minister persuaded the banks to roll back the interest increase by accepting their social responsibility to solve the housing crisis?

Mr. Danson: Mr. Speaker, we make regular contacts to keep tuned in to the mortgage situation. I am not at all satisfied yet that mortgage rates have stabilized and I am continuing to watch them carefully. I am not so much concerned whether the banks are aware of their responsibility in this regard; I am more concerned at the moment that mortgage money comes onto the market at the lowest possible level in view of the cost of money, and that it is coming in sufficient quantity to provide housing that Canadians can afford.

SUGGESTION CMHC PREPARING NEW MEASURES TO DEAL WITH EMERGENCY SITUATION—REQUEST FOR CONSULTATION WITH PROVINCES
