- 3. How much is allocated to Project 3, Community Planning, for (a) Sub-project 1, Housing Needs Survey (b) Sub-project 2, Terrain Analysis and Photogrammetric Contour Mapping (c) Sub-project 3, Legal surveys and, in each case, how many (i) Indian or Metis people are involved and what is the allocation of funds to each group (ii) departmental or resource people are involved and what is the cost of their services?

Mr. Cliff McIsaac (Parliamentary Secretary to Minister of Regional Economic Expansion): The reply for the Department of Regional Economic Expansion is as follows:

1. Yes. The Canada-Saskatchewan Interim Subsidiary Agreement on the Saskatchewan Northlands allocates \$7,320,000 to the program.

- 2. (a) As of March 31, 1976, \$4,861,680 in DREE funds have been authorized; (b) A number of northern communities with a total population of approximately 9,000 will be served by the program. A high percentage of the population is made up of people of native ancestry. Priority is also given to the employment of northern people in the construction of individual sub-projects. Funds are not specifically allocated to people of native ancestry; (c) See reply to question No. 5,282, 2(a)(ii).
- 3. (a) As of March 31, 1976, \$59,355 in DREE funds have been authorized. Two northern communities, Buffalo Narrows and Green Lake, with a total population of approximately 1,700 will be served by the sub-project; (b) As of March 31, 1976, \$18,312 in DREE funds have been authorized. The community of Cumberland House, with an approximate population of 938 will be served by the sub-
