# FEDERAL EMPLOYEES ENGAGED TO ENFORCE EQUAL-RIGHTS LAWS

#### Ouestion No. 2,169-Mr. Stevens:

As of December 31 (a) 1968 (b) 1976, what was the number of federal employees engaged to enforce equal-rights laws?

Hon. John C. Munro (Minister of Labour): (a) As at 31 December 1968, the Canada Department of Labour, administered the Canada Fair Employment Practices Act (which [Mr. Knowles (Winnipeg North Centre).] became Part I of the Canada Labour Code in 1971) and the Female Employees Equal Pay Act (which later became a clause in Part III of the Canada Labour Code). The Fair Employment Practices Branch had the responsibility of administering these two Acts and four full-time employees were employed in the branch. The Industrial Relations Officers located in the nine field offices across Canada worked parttime as required in completing the investigations. (b) December 31, 1976–28.

#### NATIONAL DEBT

#### Ouestion No. 2.213-Mr. Woolliams:

1. What is the total amount of the unfunded national debt over the past ten years?

2. How much of the interest on this indebtedness has been paid to (a) Canadians (b) foreign countries and, in each case, in what form?

Mr. Bob Kaplan (Parliamentary Secretary to Minister of Finance): 1. The national or public debt, as reported in the Public Accounts of Canada, consists of unmatured debt outstanding and other liabilities. The latter, which is generally regarded as the unfunded debt of Canada includes both non-interest bearing liabilities and interest bearing liabilities. Table I shows the level of the unfunded debt at March 31, 1966 and at March 31, 1976.

2. Total interest on the unfunded debt amounted to \$230.3 million in 1965-66 and \$1,023.0 million in 1975-76. All this interest is payable to Canadians. Table 2 indicates the breakdown by category of these interest costs.
