## DEMAND FOR MINISTERS' RESIGNATIONS—MOTION UNDER S.O. 43

**Mr. Gordon Taylor (Bow River):** Madam Speaker, I rise on a matter of urgent and pressing necessity, under Standing Order 43. Whereas the Prime Minister (Mr. Trudeau) won the last election by defaming the 18 cent per gallon increase on gas and promising a smaller increase; and whereas the Prime Minister has already, since his re-election, increased gas prices more than double the 18 cents and applied the increase also to heating oils and farmers, and has levied a \$2.50 per barrel petroleum compensation charge to pay the subsidy on foreign oil at \$40 per barrel while Canadian farms and businesses are going bankrupt and cash and jobs are being exported out of Canada to the point where the country is on the verge of breaking up, I move, seconded by the hon. member for Peace River (Mr. Cooper):

That this House demands the resignation of the Prime Minister and the Minister of Energy, Mines and Resources immediately. Canada does not need nor want persons at the head of our government who deceive the people and who are strangers to the truth.

## SPORTS FISHING REGULATIONS IN BRITISH COLUMBIA—MOTION UNDER S.O. 43

They are also confused and have their own interpretation of those regulations, based on news media reports and rumours. Therefore I move, seconded by the hon. member for Skeena (Mr. Fulton):

That the Minister of Fisheries and Oceans resign his cabinet position and immediately create a fourth position in his west coast information service for himself so that he can take on the primary task of distributing definitive regulations for the 1981 salmon season to all segments of the sports fishing and tourist industries.
