PREMIER'S STATEMENT

Mr. Brian Tobin (Humber—Port au Port—St. Barbe): Mr. Speaker, is the Minister aware that a large part of the reason for the uncertainty is that yesterday in Newfoundland a statement was made by the Minister confirming that negotiations are ongoing, and an absolute denial was made by the Premier of Newfoundland that negotiations actually exist? Can the Minister tell us why that very large contradiction exists between the statement of the Minister, the Hon. Member for St. John's West, and the denial by Premier of Newfoundland? Newfoundlanders have suffered long enough from an uncertainty caused, I suspect, by confederation-building in Newfoundland at this time.

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, it is perhaps a matter of semantics. There have been discussions, and perhaps they could be referred to as negotiations, but I can confirm to the Hon. Member that there have been discussions. Those discussions will continue until such time as an agreement can be reached more or less in principle, after which time we will set out to consult with the people of Newfoundland, the communities, and particularly the workers involved.

OWNERSHIP OF IMASCO
