# **Oral Questions**

The only thing I can confirm right now is that we are investigating one leak, which is the one that resulted in Doug Small getting a copy of that publication.

Who is telling the truth? Is the RCMP investigating one leak or two leaks? If it is investigating a second leak, why can the Minister not give us the information as to when the Minister of Finance knew about the second leak? He can supposedly tell us who profited and who did not. Why can he not tell us when the Minister of Finance knew?

Hon. Pierre Blais (Solicitor General of Canada and Minister of State (Agriculture)): Mr. Speaker, I can only repeat what I said earlier. There is a difference between leaks and allegations, a big difference. I said yesterday that I have been informed by the Commissioner of the RCMP that so far, there is no evidence of profiteering by anyone from the Budget leak. What I said was that I was informed by the Commissioner and there is nothing more I can add to that.

### CONTRADICTION IN STATEMENTS

Mr. Russell MacLellan (Cape Breton—The Sydneys): Mr. Speaker, there is a tremendous contradiction here. We are told that we cannot have information that is as a result of an RCMP investigation. We are told that no one is profiting from this, something which must be part of the RCMP investigation. Yet we cannot have an answer to the simple question, when did the Minister of Finance know about this leak? This is a flagrant disregard for the rules of Parliament.

Pierre Blais (Sollicitor General of Canada and Minister of State (Agriculture)): Mr. Speaker, I think that it was responsible to inform this House when the Commissioner of the RCMP informed me himself that to date we had no information or any evidence that anyone profited from the leak. I think that Canadian people should be reassured and know exactly what is going on. And this is what I did; I informed the House.
