### POINT OF ORDER

#### THE OFFICIAL REPORT—CLARIFICATION OF COMMENTS

**Mr. Nelson A. Riis (Kamloops):** Mr. Speaker, one of the recommendations made in the report reminds me that the Hon. Member for Saint-Laurent (Mrs. Maheu) rose yesterday to make a statement regarding the Hon. Member for Vancouver East (Ms. Mitchell). I would simply like to reply on behalf of the Hon. Member for Vancouver East to clarify any misunderstanding that may exist regarding her question of June 22, as reported at page 3557 of *Hansard*, which was directed to the Hon. Member for York West (Mr. Marchi). When she said that the Liberal critic for multiculturalism would oppose the re-establishment of a separate Standing Committee on Multiculturalism, she was referring to the Hon. Member for Broadview—Greenwood (Mr. Mills), she was not referring to his co-critic, the Hon. Member for Saint-Laurent, who yesterday clarified that she supported a separate Standing Committee on Multiculturalism.

**Mr. Speaker:** The Chair thanks the Hon. Member.

**Hon. Doug Lewis (Minister of Justice and Attorney General of Canada):** Mr. Speaker, I rise on a point of order. There have been discussions with the Parties and I think you would find unanimous consent for the Government to introduce two Bills which are shown on the notice paper. The purpose of introducing these today would be to enable them to be printed and to allow some time over the next few weeks for them to be considered. I am referring to the Bills presently on the Order Paper standing the name of the Minister of Finance (Mr. Wilson), a Bill entitled an Act to amend the Federal Provincial Fiscal Arrangements and Federal Post-secondary Education and Health Contributions Act, and a Bill standing in the name of the President of the Privy Council (Mr. Mazankowski) entitled an Act to establish the Canadian Centre for Management Development and to amend certain other Acts in consequence thereof.

### Introduction of Bills

**Mr. Riis:** Mr. Speaker, we have noticed the Bills on the notice paper and while we have some concerns with some of them, we will certainly support their introduction to expedite the matter. I would simply like to inform the Government House Leader that we are still waiting for Bills on an ethics package, a federal environmental assessment process, a child care program, broadcasting copyright, bankruptcy law and water quality. There is a whole list of Bills for which we are waiting and I was hoping we could see those on the notice paper today. Perhaps the Minister could give us an indication of when we would see some of these Bills brought forward.

**Mr. Lewis:** Mr. Speaker, my hon. friend will remember that on November 21, we were elected for five years. During the course of our mandate, he will see those Bills.

**Mr. Milliken:** Mr. Speaker, I want to confirm the arrangement to permit the introduction of the two Bills that the Minister of Justice (Mr. Lewis) is seeking leave to introduce today. I must say that I agree with my hon. friend from Kamloops with respect to the dilatory nature of the movement on some of these other matters, but that is not a matter that we can usefully debate in the House this afternoon.
