Ms. Sheila Copps (Hamilton East): On a point of order, Mr. Speaker.

I have just listened to the lovely rhetoric of the new leader of the Bloc Quebecois. Perhaps I am mistaken, but it seems to me that when he was Minister of Environment in the Conservative government he supported the Hibernia project.

Mr. Bouchard (Lac-Saint-Jean): Mr. Speaker, with regard to the environment, everybody knows but nobody mentioned it except the hon. member a moment ago, that no other project has ever undergone as many environmental studies before being brought forward. When I was Minister of Environment and a very strict minister as that because many criticisms were levelled at me in economic circles, I have attested, and I can reaffirm it now that in that project everything has been done to protect the environnment.

We do not criticize the legislation from the environmental point of view. What we criticize and find unacceptable are the conditions under which the project is to be economically and technologically realized. Certainly, Mr. Speaker— I would like to conclude my remarks, with your permission.

Ms. Sheila Copps (Hamilton East): On the same point of order, perhaps, Mr. Speaker. I find it a bit confusing because at the time he was a minister, he was unconditionally for the project. Is he mixed up or what?

## **FISHERIES**

It seems to me the deal that was signed helps Quebec immensely. It helps less so the maritime provinces, such as Nova Scotia, New Brunswick and P.E.I. who would be looking for the work.

However, last May 8 I rose in the House and, just after he had tabled his amendments to the Fisheries Act, I asked the minister about the penalties that he was planning to bring in at that time. The question was about the fines up to \$1 million for harmful alteration, destruction or disruption of fish habitat.

I asked on that day in particular because I knew there were 42 foreign boats fishing in what was called the silver hake box, while our own fishermen were not able to fish in that area at that time because of the spawning ground rules. The odd part is that they were fishing right beside the spawning grounds. They are allowed a by-catch of the traditional fish in the spawning grounds.

It just seems that the government—and I am looking forward to hearing more about these amendments as they come into play—was hitting at the people who are least able to pay the penalties, our own Canadians, when we have foreigners out there fishing and overfishing, yet we cannot impare the same type of penalties on them.

I know the Minister for International Trade signed an agreement with the Americans whereby they would look to have a uniform system as a guide to prosecuting Americans in our waters. I know the American system and I have seen how it works. That agreement is only worth the ink on that paper, because I cannot see the eastern seaboard American states agreeing very rapidly
