ARTICLE V.

OF THE CORPORATION.

(Passed 11th January, 1854. Amended 6th February, 1889.)

All members of the Church of England, subscribing \$2 per annum, shall be capable of being elected members of the Corporation. But no person shall enjoy any of the privileges of membership, whose subscription is more than one year in arrear. The annual subscriptions shall be considered due on the first day of January in each year.
