## UPRISING IN INDIANS

Some of Uncle Sam's Regular Soldiers Killed by Redskins, Who Attacked Them From Ambush—The Troops Are At Present Entrenched, But the Situation is Grave—The Fight Was a Hot One—Indian Losses Unknown.

Minneapolis, Oct. 5.—A battle took place this morning between United States regulars, under Gen. Bacon, and Barland Indians, in which four soldiers were killed and nine wounded. How many Indians were killed is not at present known. Gen. Bacon had gone to Bear Island to enforce the authority of the United States marshal in that district. The marshal had arrested several Indians for various offences, but the other Indians on the reservation rescued their brethren and would not give them up.

According to a despatch to the Journal from Walker, Minn., Gen. Bacon, with his force of 100 regulars, who were on small river steamers, reached a point close to Bear Island early this morning and proceeded overland towards the Indian reserve. During a halt, and while preparations were being made for dinner, the Indians opened fire on the regulars. The Indians were concealed in the bushes, and the soldiers at once sought shelter themselves. The firing at once became general.

A body of Indians, said to number 150 or 200, made a rush towards several deputy marshals, who had two prisoners in their possession, but the regulars' heavy fire beat them back. Six Indians were seen to fall during the rush. The Indians then ran to the shore and fired volley after volley at the steamers that had carried the troops. Inspector Tinker, who was on the tug boat Chief, was shot through the leg, and the steersman of the Jennie was shot in the arm.

Later reports say the regulars are stretched, and will make no further move until reinforcements arrive.

A Startling Rumor.  
St. Paul, Minn., Oct. 5.—An unconfirmed rumor has reached here that the soldiers and General Bacon had been massacred by the Indians at Leech Lake.

Washington, D.C., Oct. 5.—Official despatches received here tonight brought to the attention of the public the sudden realization of an Indian rising of more than ordinary dimensions. These despatches began coming about 6 p.m., two of them coming to Secretary Bliss, who as head of the Interior Department, has charge of General Griggs, and a third to the United States marshal at the seat of the uprising. The first despatch to Secretary Bliss was as follows:

Walker, Minn., Oct. 5.  
"Secretary of the Interior, Washington.  
"The Indians, who are on the island of North Bear Island, opened fire on troops under command of General Bacon without warning this morning at 11.30. I fear the army in the field is not strong enough to subdue the Bear Island Indians. How many are hurt on their side cannot be told. A large force should be sent to the island."

## HEAVY BANK ROBBERY

Sixty-Two Thousand Dollars Missing From the Vaults of the Winnipeg Branch of Moisons Bank—The Napanee Robbery Discounted—Police and Officials Are Dumb—A Great Sensation.

Winnipeg, Oct. 5.—The Moisons Bank in this city has been robbed of a large sum of money, said to be in the neighborhood of \$60,000. The bank officials and solicitors are very reticent in regard to the matter, although they do not deny that the bank has been robbed. The details of the affair are kept from the public.

Mr. T. B. Pheoq, manager of the bank, left yesterday morning for Russell on a shooting trip and Mr. F. McEeth, accountant and acting manager of the bank during Mr. Pheoq's absence, was seen by a reporter. His statements were extremely guarded. For any inquiries of such a nature, he said, I must refer you to the bank's solicitors, under whose direction I act during the absence of the manager.

The robbery was not discovered until yesterday at noon, so that it can safely be inferred that the safe was not broken into, or any evidence left in the building by the robbers.

In fact, it is asserted that the vault was opened by the regular combination. This adds much to the mystery, as only one man in the bank knows the whole combination, each clerk who uses the vault locking a portion. It is said that the money stolen was in bank notes, and the robbery is believed to have taken place since Sept. 28.

It is not impossible that arrests will be made before another day goes by. The absence of any official statement is particularly accounted for by apparent lack of authority in the part of both acting manager and solicitors to give out any information. They both declare that they have no authority to make anything public.

Mr. Wolferstan Thomas of Montreal, general manager of the Moisons Bank, confirms the report of the robbery. He was notified early this morning that \$62,000 had been taken. Out of this \$25,000 was in negotiable notes, so that \$37,000 is the real loss of the bank. Manager Pheoq has been communicated with and will be back in the city this evening.

Instructions, in consequence of the robbery, have been issued from the head office of the bank in Montreal, to the various branches, to keep a man on guard at nights over the vaults until further notice.
