"You swear (or solemnly affirm) that you are the person mentioned on the list of voters now shewn to you (shewing the list to the voter) under the name of (name of the voter as entered on the list) that you were justly entitled as owner (or as tenant or occupant as the case may be) to have your name inserted as a voter in the said list, and had in good faith the property qualification in respect of which you appear as such voter on the said list; that you are a subject of Her Majesty by birth (or naturalization); that you are of the full age of twenty-one years; that you have not before voted at this election, either at this or any other polling place, and that you have not received anything nor has anything been promised to you, either directly or indirectly, in order to induce you to vote at this election. So held you God," inserted instead thereof.

concurrence.
