### FORECLOSURE OF FARM MORTGAGES

APPEARANCE OF DOCTOR D. A. MACGIBBON BEFORE
AGRICULTURE COMMITTEE OF MANITOBA
LEGISLATURE

On the orders of the day:

Mr. J. L. BROWN (Lisgar): Mr. Speaker, I should like to ask the Minister of Trade and Commerce as to the correctness of an article appearing in the Winnipeg Free Press of March 29, 1932. It is stated here that Mr. D. A. MacGibbon, who is a member of the Board of Grain Commissioners has been refused permission by the Deputy Minister of Trade and Commerce in Ottawa to appear before a committee of the Manitoba legislature which is making an inquiry regarding possible methods of debt adjustment for farmers who are threatened with foreclosures. If that statement is true, is it done with the authority of the minister, and why?

Hon. H. H. STEVENS (Minister of Trade and Commerce): The statement is not strictly correct. It is broached in terms that are calculated to be misleading and to create controversy. The facts are these: Doctor MacGibbon was asked to appear before that committee and discuss a certain resolution which was presented to this house. Doctor MacGibbon wired and asked if it was thought desirable for him to appear and discuss the matter. The answer given to Doctor Mac-Gibbon, which I think coincided entirely with his own view in the matter, was that it was undesirable for him, a public servant holding a quasi-judicial position to be involved in a matter which was of a controversial, or might be of a controversial, character, and which certainly was purely provincial. It was my judgment, the judgment of the deputy minister and I think that of Doctor MacGibbon himself, that it would be better for him not to participate in a matter of that character.
