Mr. GARDINER: The province submits an account for the total amount that should be paid up to that date. Our auditor then checks the accounts-I understand that he has been able to check them inside of twentyfour to forty-eight hours after receiving them -and if he is satisfied, he notifies Ottawa and Ottawa advances the amount necessary to cover those particular accounts. The auditor checks further in order to see that the money goes to pay those accounts and not something else.

Mr. BENNETT: That is what I was anxious about.

Mr. GARDINER: I do not think there has been any difficulty about that, either in Alberta or in Saskatchewan.

Mr. BENNETT: I have had complaints that men in Manitoba have not received their money.

Mr. GARDINER: There is just a possibility that the complaints you speak of may be provincial in character. There is what is called a federal and a provincial area. The province carries on transactions with money it itself is handling, apart from what we put up. There may be some difficulty with payments, but I do not know of any.
