Resolution reported, read the second time and concurred in.

Mr. Harris (Grey-Bruce) thereupon moved for leave to introduce Bill No. 319, for granting to His Majesty certain sums of money for the public service of the fiscal year ending March 31, 1951.

Motion agreed to, and bill read the first time.

Mr. Harris (Grey-Bruce) moved the second reading of the bill.

Mr. Drew: We have got things through quite satisfactorily tonight and I think the second reading should be left over until tomorrow. Hon. members will then have an opportunity to examine the bill, which I am sure is in exact form, before it is passed.
