ELLIOT LAKE URANIUM MINERS—RESPONSIBILITY FOR SAFETY VESTED IN ATOMIC ENERGY CONTROL BOARD—MOTION UNDER S.O. 43

ADMINISTRATION OF JUSTICE

MENTALLY HANDICAPPED—CASE OF EMERSON BONNAR— MOTION UNDER S.O. 43

Mr. Neil Young (Beaches): Madam Speaker, I rise under the provisions of Standing Order 43. Over 800 Canadians, many of them mentally retarded individuals, are being detained in institutions for long periods subsequent to being charged with committing a crime. Being found not fit to stand trial or not guilty on account of insanity, they are committed to those institutions under the Lieutenant Governor warrant provisions of the Criminal Code for indefinite periods.

One person who has never had benefit of a trial is Emerson Bonnar of New Brunswick, who has been detained since 1964, at which time he was charged with attempting to steal a handbag. I move, seconded by the hon. member for Winnipeg North Centre (Mr. Knowles):

That this House request the Minister of Justice to investigate immediately the case of Emerson Bonnar with a view to securing his release from this cruel and unusual treatment, and that the minister bring before this House legislative proposals based on the recommendations of the 1976 report of the Law Reform Commission of Canada so that mentally handicapped and mentally disabled Canadians charged with an offence are entitled to a fair trial before the law.

INCOME TAX

PER DIEM MEALS ALLOWANCE FOR COMMERCIAL TRAVELLERS—MOTION UNDER S.O. 43
