DEARTH PREVENTS TEST

CHICAGO, Nov. 13.—(Can. Press.)—Scarcity of radium has prevented a thorough test of what its curative properties may be in cancer, according to the report made to the clinical congress of surgeons in session here by the cancer campaign committee.

"Only time will tell what percentage of cases can be cured with radium," the report states. "In the meantime the public should be informed that every possible source that early surgical treatment offers the best chance for cure."

The surgeons who have reported the best results from radium still urge early operation whenever possible.

### SYNOPSIS OF DOMINION LAND REGULATIONS.

ANY PERSON who is the head of a family, or who is at least 21 years of age, may, on application to the Dominion Lands Agency, obtain a homestead of available Dominion land in Manitoba, Saskatchewan, Alberta, or the Northwest Territories. The application must appear in person at the Dominion Lands Agency or its Agency for the District. Entry by proxy may be made at any agency, on certain conditions, by father, mother, son, daughter, brother or sister of intending homesteader.

Duties. Six months residence upon and cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 32 acres. A homesteader, and occupied by him or by his father, mother, son, daughter, brother or sister, in certain districts a homesteader in good standing may pre-empt a quarter-section alongside his homestead, at \$1.00 per acre.

Duties. Must reside upon the homestead or pre-emption six months in each of six years from date of homestead entry (including the time required to earn homestead patent), and cultivate fifty acres extra.

A homesteader who has exhausted his homestead right and cannot obtain a pre-emption must wait a year before he may homestead in certain districts. Price \$2.50 per acre. Duties. Must reside six months in each of three years, and cultivate fifty acres and erect a house worth \$300.
