POSTAL CONVENTION OF THE AMERICAS AND SPAIN

CONCLUDED BETWEEN

CANADA, ARGENTINA, BOLIVIA, BRAZIL, CHILE, COLOMBIA, COSTA RICA, CUBA, DOMINICAN REPUBLIC, ECUADOR, GUATEMALA, RICA, CUBA, DOMINICAN REPUBLIC, ECUADOR, GUATEMALA, HAYTI, HONDURAS, MEXICO, NICARAGUA, PANAMA, PARA-GUAY, PERU, SALVADOR, SPAIN, UNITED STATES, URUGUAY AND VENEZUELA.

The Undersigned, Plenipotentiaries of the Governments of the Countries above enumerated, assembled in Congress in the City of Panama, Republic of Panama, availing themselves of the powers conferred upon them by Article 5 of the Convention of the Universal Postal Union and actuated by the desire extend and improve their postal relations and ensure a solidarity of action in Universal Postal Congresses as an effective means of promoting their common interests in regard to postal communications, have determined to conclude, sublect to ratification, the following Convention:

ARTICLE 1

Postal Union of the Americas and Spain

In accordance with the foregoing declaration, the contracting countries con-Stitute, under the title of Postal Union of the Americas and Spain, a single Postal territory.

ARTICLE 2 Restricted Unions
