Hon. Paul Martin (Secretary of State for External Affairs): 1. The Department of External Affairs cannot say how many persons may have applied for passports for the specific purpose of entering Israel or Egypt during the recent war for the reason that Canadian passports are issued valid for travel to all countries and passport applicants are not asked to state the countries to which they plan to travel. Visas to enter Israel and Egypt are not issued by the Canadian Government but must be obtained from the Israeli and Egyptian authorities.

- 1. How many federal parks are there in each of the provinces of Canada?
- 2. What is the area of these federal parks?
- 3. How much has the federal government spent on federal parks to date?
- 4. Do some provinces not have federal parks and, if so, for what reason?

Hon. Arthur Laing (Minister of Indian Affairs and Northern Development): 1. British Columbia, 4; Alberta, 5; (including Wood Buffalo national park, partially in Alberta and partially in the Northwest Territories); Saskatchewan, 1; Manitoba, 1; Ontario, 3; Quebec, 0; New Brunswick, 1; Nova Scotia, 2; Prince Edward Island, 1; Newfoundland, 1.

- 2. Total area, 29,416.2 square miles.
- 3. \$238,362,741 to the end of fiscal year 1966-67.
- 4. There are as yet no national parks in the province of Quebec. The addition to the national parks system of one or more outstanding examples of Quebec landscape would indeed be welcomed by my department. However, the establishment of new national parks is dependent upon the province concerned taking the initiative. Customarily the province invites the federal government to participate in a joint survey of potential
