**TRANSPORT****SHORTAGE OF RAILWAY CARS FOR BRITISH COLUMBIA LUMBER—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION**

That this House expresses its regret that the government has taken the course of denying lumber producing areas the same consideration that has been extended to grain producing areas in so far as it is assisting railway companies to renovate and repair boxcars.
