which would declare Canada to be a country which is multilingual by nature. It may well be desirable to enhance multilingual programming, but to change the nature of Canada by implication through such an amendment is not appropriate. We are a multicultural and bilingual nation.

I would further point out that there is ample avenue provided for multicultural service, not ghettoed, ample avenue provided for multicultural programming in the new alternative programming service which, indeed, will become a stimulus to other broadcasters to recognize further the multicultural nature of our country.

Motion No. 72 would call upon the legislation to insist that one director of the corporation be designated as the advocate for multicultural and ethnic organizations. I would submit that that is inappropriate since, as my colleague from Thunder Bay pointed out, Bill C-93 is now the law of the land. Every Minister of the Crown, every officer of an agency of the Crown, now has a duty to see that that advocacy role is carried out. To single out one individual to do it is inappropriate and demeaning.

I would further suggest, Sir, that a member of such a board who might fit that designation would be offended to think that he or she had his or her role limited to such a function. We do not subscribe to tokenism in this country.

The Acting Speaker (Mr. Paproski): The Hon. Member for Vancouver—Kingsway knows, because he has been around here for a long time, that he would have to have unanimous consent of the House to withdraw the motion.

Is the House ready for the question?
