VIA RAIL

Mrs. Marlene Catterall (Ottawa West): Mr. Speaker, I am pleased to present a petition that comes from communities across Ontario expressing concern about the impact on the tourism industry and on Canadians of the cuts to VIA Rail, and asking that the government not continue with these cuts.

VIA RAIL

Mrs. Beryl Gaffney (Nepean): Mr. Speaker, I am pleased to stand this morning, pursuant to Standing Order 36, to present petitions, 52 from the Belleville and Tweed area of Ontario, and 60 from the Brockville area of Ontario, which are opposed to the government's measures to cut back on VIA Rail across this country. The petitioners are very concerned about the loss of thousands of jobs. They feel that a proper analysis has not been done, where a disproportionate subsidy is required for highway infrastructure or airports, as opposed to VIA Rail. These petitioners humbly pray and call upon Parliament to urge the Government of Canada not to cancel, in whole or in part, rail passenger services in Canada.

FISHERIES

Ms. Lynn Hunter (Saanich—Gulf Islands): Mr. Speaker, I rise, pursuant to Standing Order 36, to present a number of petitions. The first petition relates to the outrage felt by people in my riding, both on the Saanich Peninsula and on the Gulf Islands, to the horror of drift-net fishing that is occurring in the north Pacific. As my colleague from Nanaimo—Cowichan says these drift-nets are curtains of death. Over 500 people in my constituency alone have signed this petition. They call upon the government to act. PROPOSED GOODS AND SERVICES TAX
