he endeavored to induce game warden Wyse to back-date the license which he applied for, after he knew that his violation of the law was likely to get him into trouble. It is a fact and a childish evasion for Dr. Cox to intimate that anyone has objected to his not "having a license in his pocket at the very time." His offense was that he treated the law with contempt by not having a license at all in his pocket or anywhere else. The law says (Sec. 30, Chap. 8, Sec. 6):

Every person who is guilty of an offence and liable to the penalty hereinafter provided, who, during any open season for moose, caribou or deer:

(a) Hunts, takes, hurts, injures, shoots, wounds, kills or destroys

(b) Any moose, caribou or deer without being the holder of a license so to do, as provided for in Sec. 30.

Sec. 30 provides—amongst other things—that the license may be obtained from the Surveyor General, Chief Game Commissioner or any Warden, and a subsequent section (41) fixes the price at \$2.

Dr. Cox entirely ignored the law and he now endeavors to set up a law of his own, viz.—that men may first get hunting and afterwards obtain the license so to do. It is needless to say that there are men who do this, but it is somewhat in the nature of a surprise to find Dr. Cox ranging himself with them and advocating the practice.

The law should, however, be upheld and he must be made to understand that he is not above it. It is not to his credit that a person in his position should set the example he has done in the community to those who may be all too ready and willing to follow it and take their chances for escaping detection, just as he did.
