

MANTIK Reg. No. 18730, ex-S/Sgt. Adolf Mantik, 55, died April 4, 1990, at Duncan, British Columbia. He was born March 26, 1935, at Bonnyville, Alberta, and joined the Force September 13, 1954, at Edmonton. Upon completion of training at "N" Division, Rockcliffe, Ontario, Mantik was posted to "E" Division, British Columbia, where he spent his entire service at Prince George, Hope, Shawnigan Lake and Victoria. He retired November 1, 1981. Mantik was promoted to corporal May 1, 1967; sergeant June 1, 1973, and staff sergeant October 1, 1975.

MILNE Reg. No. 13557, ex-Cst. William Sang Milne, 67, died December 17, 1989, at Winnipeg, Manitoba, where he was born May 31, 1922, and joined the Force July 29, 1940. Upon completion of training at Depot Division, Regina, Saskatchewan, Milne was posted to "K" Division, Alberta, and served at Lethbridge, Pincher Creek and Coutts. On November 9, 1942, he was transferred to Depot Division and took his discharge January 22, 1943.

MURRAY Reg. No. 13306, ex-Sgt. Kenneth Vaughan Murray, 73, died January 25, 1990, at Lunenburg, Nova Scotia. He was born December 3, 1916, at Halifax, where he joined the Force March 27, 1940. Upon completion of training at Depot Division, Regina, Saskatchewan, and "N" Division, Rockcliffe, Ontario, Murray was posted to "H" Division, Nova Scotia, where he served at Halifax, Bridgewater, Barrington Passage and Glace Bay. He retired to pension March 26, 1965. Murray was promoted to corporal November 1, 1952, and sergeant November 1, 1960.

NICKEL Reg. No. O.871 (17327), Supt. James Russell Nickel (retired), 60, died March 30, 1990, at Vancouver, British Columbia. He was born February 9, 1930, at Winnipeg, Manitoba, where he joined the Force November 1, 1951. Upon completion of training at Depot Division, Regina, Saskatchewan, and "N" Division, Rockcliffe, Ontario, he was posted to "D" Division, Manitoba, and served at Winnipeg. On August 17, 1952, he was transferred to Depot Division for second part training, and upon completion of training, was posted to "F" Division, Saskatchewan, and served at Nipawin, Uranium City, Tisdale, Regina, Kipling, Punnichy, Hudson Bay and Swift Current. Nickel was transferred to "D" Division, Winnipeg, on July 2, 1974, to "F" Division, Regina, on August 29, 1978, and retired on October 31, 1986. He was promoted to corporal May 1, 1963; sergeant May 1, 1968; staff sergeant June 1, 1972; inspector April 1, 1974, and superintendent July 16, 1983.

NOTT Reg. No. 16426, ex-Cpl. Stanley Thomas Nott, 81, died April 15, 1990, at Vancouver, British Columbia. He was born March 15, 1909, at Kamloops, British Columbia, and became a member of the Force upon the amalgamation with the British Columbia Provincial Police on August 15, 1950. Nott was posted to "E" Division, British Columbia, and

served at North Vancouver and Richmond. On August 1, 1951, he was transferred to "K" Division, Alberta, and was stationed at Edmonton. He returned to "E" Division June 25, 1962, served at Richmond, and retired to pension on July 27, 1965. He was promoted to corporal May 1, 1961.

RODDA Reg. No. O.541 (13340) Insp. Nigel Frank Rodda (retired) 72, died March 31, 1990, at Ottawa, Ontario. He was born July 22, 1917, at London, Ontario, and joined the Force April 9, 1940, at Toronto. Upon completion of training at Depot Division, Regina, Saskatchewan, Rodda was posted to "K" Division, Alberta, and served at Edmonton and Red Deer. He was transferred to "N" Division, Rockcliffe, Ontario, on August 1, 1941, and to "A" Division, Ottawa, on May 4, 1942. Rodda took his discharge on April 8, 1945, and reengaged on July 12, 1949, at Ottawa. He served in Staffing and Personnel at Ottawa, Toronto, St. John's, Newfoundland, and Headquarters, and retired to pension December 29, 1973. Rodda was promoted to corporal May 1, 1952; sergeant May 1, 1958; staff sergeant November 1, 1961; sub-inspector September 1, 1962, and inspector September 1, 1964.

ROWETT Reg. No. 19453, S/Sgt. Donald Glen Rowett, 52, died January 29, 1990, at Richmond, British Columbia. He was born February 9, 1937, at Vancouver, where he joined the Force May 28, 1956. Upon completion of training at "N" Division, Rockcliffe, Ontario, Rowett was posted to "K" Division, Alberta, where he served at Lethbridge and Taber. He was transferred to "A" Division, Ottawa, June 6, 1960, to "F" Division, Saskatchewan, August 18, 1963, and served at Kamsack. On August 11, 1966, Rowett was transferred to "E" Division, British Columbia, and worked at Surrey and Richmond, where he was serving at the time of his death. Rowett was promoted to corporal June 1, 1969; sergeant February 7, 1977, and staff sergeant January 8, 1979.

ROZKA Reg. No. 27052, ex-Cst. Richard Franklin George Rozka, 40, died March 16, 1990, at Edmonton, Alberta. He was born December 17, 1949, at Elk Point, Alberta, and joined the Force January 23, 1969, at Edmonton. Upon completion of training at Depot Division, Regina, Saskatchewan, and "P" Division, Penhold, Alberta, Rozka was posted to "E" Division, British Columbia, and worked at Surrey. He was transferred to Headquarters, Ottawa, on July 27, 1972, and was posted to "J" Division, New Brunswick, on September 1, 1973. On December 1, 1974, Rozka was transferred to "E" Division, Vancouver, British Columbia, and invalided to pension on October 22, 1979.

UMPERVILLE Reg. No. 14176, ex-Cpl. Malcolm John Umperville, 69, died March 7, 1990, at Edmonton, Alberta. He was born August 16, 1920, at The Pas, Manitoba, and joined the Force July 5, 1941, at Winnipeg. Upon completion of training at Depot Division, Regina, Saskatchewan, Umperville
