Members of Last Year's Council Indignant Over Blanket Insinuation Published Yesterday Afternoon-Demand That Names and Facts Be Given or Apology Made.

MUST MAKE GOOD CHARGES OR WITHDRAW THEM

Have members of the city council been drunk while in performance of duty? If so, who are they?

These plain questions demanding plain answers face the London Free Press as the result of an article published in that paper yesterday afternoon.

The article, which is quoted in the next column, is an insinuation that the city council of 1923 indulged in drunkenness during the execution of the city's business, and that, because of such drunkenness, restrictions should now be placed on the council of 1924 to prevent its repe-

INSINUATION IS SERIOUS.

Whatever the motive may have been in making the insinuation, its effect is serious. Members of the city police force or of the fire department would be summarily dismissed if guilty of such conduct, and similar offences by aldermen or by mayor could not be tolerated in any city.

Four members of the 1923 council stated to The Advertiser today their demand that: 1. The insinuation of drunkenness be proven in de-

2. The article be retracted in entirety.

This demand comes from George Burdick, former alderman of Ward Four; John Colbert, former Labor alderman of Ward Three, and president of the Street Railwaymen's Union; Alderman Edmund Hayden of Ward Four, prospective chairman of the 1924 Board of Works, and Alderman Gordon Drake of Ward Three.

Other members of last year's council wish to withhold statements until opportunity is given for withdrawal of the defamatory article.

Ex-Ald. Burdick, in expressing his indignation, described the article as a "despicable and unwarranted attack" on those who have given their best efforts in the interest of the city and those who elected them.

An unusual scarcity of northern win-





Bandit Gang Under Ryan Had Laid Plans to Rescue Ed. McMullen From 'Pen'

The Arrangements Failed, But Through No Fault of "Red" Ryan's, It Is Claimed.

WAS KEPT POSTED

Kingston, Jan. 9 .- Startling ideas and big plans for a scheme that would have startled Ontario was concocted in the brain of Norman "Red" Ryan during the four months he was dashing about the country since he escaped from Kingston.

It was learned by The Advertiser today that Ryan had planned with the aid of an American-Canadian bandit gang of gun fighters to come right into Kingston and attempt to rescue Eddie McMullen, Wyoming bank robber who was shot and later captured after he had escaped over the wall with Ryan, Simpson, Sulli-

van and Bryans.

Ryan liked McMullen and if Mc-Mullen had not been shot down Mc-Mullen and Ryan were going to work together in robbing banks. Ryan trusted McMullen more than any of the others who escaped. Ryan and McMullen had sworn to travel together, and it was a big disappoint-ment to Ryan when he had to leave McMullen behind him in the swamp.

Ryan Planned Rescue. But McMullen was going to be

rescued when he was going to be rescued when he was on his way to the courthouse in Kingston to stand trial for his escape. Ryan had in some manner the same brainy way he engineered all his cynoditions. engineered all his expeditions to McMullen know in the peniten-

tiary that he was going to rescue him from the prison escort.

Ryan was to lead the raid into the heart of the town and intercept the party at a cross road near the courthouse. Ryan worked away on his scheme and had a gang of a dozen gunmen ready to follow him. Buchanan States Three More May Be Erected Shortly.

NINE AT PRESENT

Will Continue Testing Operations in Search For Water Wells.

Three new substations may be established in London this year, according to General Manager E. V. Buchanan who stated that three small ones were almost essential to the perfect maintenance of hydro

The location of the proposed units which would distribute about 2,000 horsepower each, would probably be widely separated. One would be built at McClary's foundry, Adelaide street, one at the Grand Trunk car shops, and the third at the corner of Caralling and Bidout streets.

At present there are nine substations in the city, No. 2 in the east end being the largest. This distributes between 8 and 10,000 horsepower. Next in size is No. 1, at the corner of Ridout and Horton streets. corner of Ridout and Horton streets where 6,000 horsepower is handled. The others are as follows: No. 3, Springbank; No. 4, Dundas street east; No. 5, Horton street; No. 6, London and Port Stanley car barns; No. 7, McClary's, York street; No. 8, Anne street; and No. 9, McCormick

factory. Will Be Abandoned.

When the one to be located at the carshops is built, the L and P. S. shop stations will be abandoned, the former being more central and in construction would be so adapted as to take care of all the requirements in this district.
