Department of Justice?

3. Are any steps being taken this session to give effect to the installation of such a system for the youth of Canada in order to improve present antiquated conditions as to youth.

Mr. LAPOINTE (Quebec East):

1. Yes.

2. The report and study of the Borstal system in England is contained in the annual report of the superintendent of penitentiaries tabled in the House of Commons, February 10th, 1936.

3. It is not anticipated that such steps will be taken to give effect to the installation of this system until the report of the commission to investigate the penal system of Canada has

been presented.

3. The apportionment of the monthly grant-in-aid within the province is left to the discretion of the provincial authorities and is not a matter of record with the dominion.
