AGRICULTURAL PRICES STABILIZATION

Mr. Samuel Boulanger (Drummond-Arthabaska): Mr. Speaker, before this first item is passed. I should like to ask the Minister of Agriculture whether he could make a statement concerning agricultural prices stabilization for the year 1961-62, and especially as regards milk products.

(Text):

Mr. Hamilton (Qu'Appelle): The government still has this matter under consideration. There has been no announcement yet.

Mr. Boulanger: When does the minister expect to make an announcement with regard to the price of butter and cheese especially, and powdered milk?

Mr. Hamilton (Qu'Appelle): The same answer applies; this is still under consider-

Mr. Regier: It is not very often that I have the privilege of speaking to an item of the Department of Agriculture. However, I cannot easily forget that I represent an industrial area. Many of the people of my constituency are pensioners, either because they are veterans of world war I or world war II or are old age pensioners. However, the bulk of the constituents whom I represent are industrial workers.

I may assure the minister at once that the industrial workers of my constituency are very much concerned about the welfare of agriculture. These union members in my riding remember very well the appeal of the Prime Minister who at the time was a leading spokesman in the opposition. They recall when the member for Prince Albert at that time, now our Prime Minister, raised his finger in anger at the prime minister of the day and said, "Canadian agriculture demands parity, not charity."

I have spoken to a great many people at many labour meetings and meetings of unionists, and each and every time I have appealed Mr. Charlton: I will obtain that information to them on behalf of agriculture for parity
