## POSSIBILITY OF CONSULTATIONS WITH PROVINCES ON MEASURES TO STIMULATE CONSTRUCTION PRIOR TO BUDGET

**Miss Flora MacDonald (Kingston and the Islands):** Mr. Speaker, my question is for the Minister of State for Urban Affairs, and it is further to his reply to me on May 2 that he would have to find ways to get housing programs moving faster. Given the critical situation in the housing sector, I would like to ask the minister if, in connection with the consensus program, he plans to meet with his provincial counterparts prior to the presentation of the budget, and if he will be proposing shelter guidelines at any such meetings.

**Hon. Barney Danson (Minister of State for Urban Affairs):** Mr. Speaker, I have spoken to my colleagues the ministers of housing in all the provinces in the last several days. I also have met with them during the consultation process. We continue a very amicable, constructive, and co-operative relationship.

**Miss MacDonald (Kingston and the Islands):** Could the minister say if there will be any formal meeting with the provincial ministers of housing prior to the presentation of the budget?

**Mr. Danson:** Formally or informally, I will be in touch with them, and we will be discussing all matters of mutual interest.

## LABOUR DISPUTES IN QUEBEC—GOVERNMENT ACTION TO CONTROL VIOLENCE

With regard to the escalation of labour disputes, and the considerable violence attached thereto, which has been such that the premier of Quebec has likened it almost to a form of war, what measures has the federal government considered to help deal with this situation and to limit the disputes within the confines of law and order?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, the hon. member should know that the disputes are now arising as a result of a provincial inquiry into the construction unions in Quebec, and the whole area remains within provincial jurisdiction. We stand ready to hold discussions with the province, if it wants to turn to us for advice, but we do not feel that it is desirable for us to intervene into one of their areas of constitutional jurisdiction.
