#### AIB—STUDY OF FOOD PRICES

### Question No. 1,373-Mr. Neil:

What was the total cost of the study carried out by the Anti-Inflation Board to determine the differences in food prices between Canada and the US?

#### RDIA—AVERAGE COST PER JOB

### Question No. 1,402—Mr. MacDonald (Egmont):

For the years 1973 to 1975, by province, what was the average cost per job created under the Regional Development Incentives Act?

Mr. Ed Lumley (Parliamentary Secretary to Minister of Regional Economic Expansion): The reply for the Department of Regional Economic Expansion is as follows: The following table provides information from 1969, the inception of the programme, to 31 December 1975, for those net accepted offers on which final payment had been made by that date. Records are not maintained in a way that permits the answer to be restricted to the period 1 January 1973 to 31 December 1975. The average cost per job created, in accordance with the foregoing, by province, is: Newfoundland, \$2,929; Prince Edward Island, \$4,481; Nova Scotia, \$6,905; New Brunswick, \$6,928; Quebec, \$2,218; Ontario, \$3,075; Manitoba, \$6,414; Saskatchewan, \$2,592; Alberta, \$4,107; British Columbia \$6,692.

## NEWFOUNDLAND—LOANS UNDER SMALL BUSINESSES LOANS ACT

#### Question No. 1,562—Mr. Marshall:

By constituency, between January 1 and September 30, 1976, what is the breakdown of the loans made in Newfoundland under the Small Businesses Loans Act?

Mr. Bob Kaplan (Paliamentary Secretary to Minister of Finance): The requested data is not maintained by electoral district but only by province, by lender, by type of business and by purpose, for the following reasons: (i) Loans are made by banks to customers who may not live in the same constituency as the bank and whose businesses may be in yet another constituency. (ii) Constituency boundaries change from time to time; thus comparative statistics cannot be maintained on a consistent basis.
