# SUPPORT FOR PROPOSED AMENDMENTS TO CRIMINAL CODE

Mr. Bill Attewell (Don Valley East): Mr. Speaker, our Minister of Justice (Mr. Crosbie) is to be praised for his proposed new legislation on pornography. With the assistance of two exhaustive studies, the Badgley Report on Child Sexual Abuse and the Fraser Report on Pornography and Prostitution, the Minister of Justice has taken action to stop the trend of excessive permissiveness.
