# ABORIGINAL RIGHTS

#### CALL FOR ENTRENCHMENT IN CONSTITUTION

Hon. Warren Allmand (Notre-Dame-de-Grâce—Lachine East): Mr. Speaker, some Canadians are asking what aboriginal rights are and why they should be recognized. Simply put, aboriginal rights are all those rights held by Indians, Inuit, and Métis which they possessed and exercised for centuries in this land before the Europeans came to this continent.

Aboriginal rights include not only certain lands and resources, but also social and cultural institutions, laws, and forms of self-government. If these rights existed before the Europeans came and they were never given up by the aboriginal peoples, then they still exist and, in justice, they must be recognized by all of us. The First Ministers' Conference scheduled for March 26 must also recognize these rights and entrench them in the Canadian Constitution.

## OPPOSITION TO PROPOSED ALBERTA LEGISLATION

Ms. Sheila Copps (Hamilton East): Mr. Speaker, I am holding a copy of Bill 14 from the Legislative Assembly of Alberta which is an insidious attempt to break down medicare. I want the federal Minister of National Health and Welfare (Mr. Epp) who is in the House today to send a direct message to the Minister of Health in Alberta telling him that we will not sell out our medicare system.

Bill 14 violates the principle of universality and the principle of comprehensiveness, the principles that the previous Liberal Government fought for to make sure that the Canada Health Act was available to all Canadians.
