**Report of Committee on Certificates and Assessments.**

The Committee appointed under section 8 of the Constitution for the examination of the certificates of election of Lay Representatives to Synod, beg to report as follows :—

1. That certificates have been furnished by 218 congregations for 263 delegates.

2. That a provision of section 3 of the Constitution, which requires that Lay Representatives "shall be elected annually *during Easter week*," which fell this year on the 29th March to April 4th (inclusive), has not been complied with by the following 21 congregations, which held their meetings on dates stated opposite their names :—
