YANGER WON OVER CALLAHAN. Chicago, Jan. 5 .- Benny Yanger, of Chicago, won a decision over Tim Callahan, of Philadelphia, in a sixround contest here tonight. Although he received the verdict. The third round and the fourth round were full of action, both men receiving considerable punishment. During the fifth and sixth rounds Yanger succeeded in reaching Callahan's stomach repeatedly with blows that were full of force. Towards the end of the last round Callahan fell into a clinch at every opportunity to avoid punishment.

BALTIMORE BANS BOXING. Baltimore, Jan. 5 .- Boxing has been ostracised in Baltimore. Unless held without the knowledge of the authorities, prizefighting of any kind will be

unknown in this city.

Mayor Hayes has determined upon this after mature deliberation, seeking, to evade the points he himself brought up in opposition to having the game one of the features of the city. His original contention was that boxing was conducive to brutality, productive of gambling and prolific of disturbances of the peace.

"If I could ameliorate these conditions and put boxing on a plane where it would command the respect worthy citizens, then I would be glad to sanction the so-called sport," said he mayor.

Many prominent figures in the Baltimore boxing world have tried to nterview the mayor in regard to his decision, but have been unable to do
