Hon. J. J. McCann (Minister of National Revenue): The answer is that no rebates will be made.

HARBOUR COMMISSIONS

NEW WESTMINSTER-EXTENSION OF BOUNDARIES AND PROVISION FOR LOAN

Hon. Lionel Chevrier (Minister of Transport) moved the second reading of Bill No. 193, respecting the New Westminster harbour commissioners.

He said: Mr. Speaker, when the resolution was being considered I made a short statement which perhaps I might amplify by saying that the bill can be divided into two parts. The first part has to do with the extension of the boundaries of the New Westminster harbour to a point northeasterly as far as Grants narrows and to a point eastward as far as New Langley. The second part of the bill has to do with the approval of a loan in the amount of \$1,250,000 by the governor in council for the purpose of allowing the harbour commissioners of New Westminster to build additional dockage facilities.

I stated on the resolution the number of (Mr. Major) asked a question yesterday and berths now in existence, but both the harbour I intimated that I had had no word from the commissioners and the city of New Westminster are of the view that additional facilities are required. The harbour commissioners have already obtained two loans from the federal government, one in the amount of \$700,000 as authorized by chapter 10 of the statutes of 1948 and the other in the amount of \$274,000 roughly as authorized by chapter 40 of the statutes of 1931.

> I have nothing more to add at this stage. After the debate is completed it is my intention to move that the bill be referred to the standing committee on railways, canals and telegraph lines for further study by that com-

> Mr. Howard C. Green (Vancouver-Quadra): Mr. Speaker, there is very little that I can add on behalf of the official opposition to what I said on the resolution stage. We approve of the measure and we are glad that it is to be referred to the standing committee on railways, canals and telegraph lines. I should like to point out to the house that this harbour commission has an excellent reputation for keeping up the interest payments on the loans which have been made. I believe it has never defaulted on these payments and I can see no possibility of there being any default if the loan as set out in this bill is granted. We believe that the council of the city of New Westminster and the New Westminster harbour commissioners are very wise in looking ahead and planning this additional dockage. It is my understanding that a bylaw will be referred to the citizens of that city to approve of the transfer of the water lots upon which the dockage is to be built. The whole project seems to be in line with the progressive and enterprising spirit that the citizens of the city of New Westminster have demonstrated for so many decades. We are very happy to support the
