Mr. Martin (Essex East): No; at any time.

Mr. Fleming: The purpose of having a resolution stage on such a measure is to provide whatever information the house requires in the later stages of the measure, and that information will be forthcoming on the resolution stage.

Mr. Speaker: I am speaking from memory, but it seems to me that there is a precedent for the statement I made that where a matter is pending on the order paper for debate it is not proper to take the time of the house to ask questions. However, I will look into the matter and not commit myself finally this morning.

WAR VETERANS ALLOWANCE INCREASES

Question No. 46-Mr. Thompson (Edmonton-Strathcona):

1. Has the ceiling on war veterans allowances been increased sufficiently to give married veterans full advantage of the increase in old age security pensions?

2. If not, have steps been taken by the government to avoid reductions in war veterans allowances

in such circumstances?

Hon. A. J. Brooks (Minister of Veterans Affairs): The answer to questions Nos. 1 and 2 is as follows. In no case does the income ceiling under the War Veterans' Allowance Act permit payment of the maximum war veterans allowance to a recipient of pension under the Old Age Security Act. The old age security pension is treated as income on the same basis as income from other sources -for instance, superannuation or disability pension. However, the recent amendments of the war veterans allowance income ceilings had the following results. In the case of a single veteran, the ceiling now permits an income of \$1,080 a year or \$90 per month, and in the case of a married veteran \$1,740 a year or \$145 per month. This is over and above exempted income or receipts from casual labour.

Hon. Paul Comtois (Minister of Mines and Technical Surveys): This question is in six parts. The answers are as follows:

1. No; no one classified as such. Radar watch is maintained by the officer of the

watch.

- 2. Yes; he informed him the rock was 20 degrees on the port bow.
- 3. Exact time not noted; approximately five minutes before grounding.
 - 4. Exactly 1632 hours; that is 4.32 p.m.
- 5. The captain always has supreme control of the ship. The senior assistant hydrographer was directing the course of the ship on a sounding line, from the hydrographers' chart room.
