These are the estimated payments proposed and, similarly, with regard to table 1 which was placed on record in *Hansard* by leave of the house on Thursday evening, those are estimated payments also. When we are making up the tables for the payments estimated to be made for the year 1959-60 we include the provision which we expect will be made by way of payments to Newfoundland of \$7.3 million, just as under the heading 1958-59 we show the preliminary figure to include the proposed payment of \$13.6 million.
