# REGISTRATIONS FOR EMPLOYMENT BY STUDENTS

# Question No. 631-Mr. Orlikow:

1. What number of High School and University Students were registered with Canada Manpower Offices for summer employment in the months of May, June, July, August, for the years 1966, 1967, 1968?

2. Of this number, how many were placed for employment and how many was the Department unable to place for employment in each of the above months for each of the above years?

Hon. Allan J. MacEachen (Minister of Manpower and Immigration): 1. Clients of Canada Manpower centres seeking temporary employment are serviced in order of registration. Students have not been identified in the past as a special group but rather as individuals who were entitled to the same service available to all clients. For these reasons statistics for 1966, 1967, 1968 on student registration at Canada Manpower centres have not been compiled separately and are not available as such.

#### Questions

2. For the same reasons mentioned above, the number of students placed for employment and the number the department was unable to place cannot be determined completely. Summer unemployment in the 14 to 24 age group, which had been at a low level in previous years, increased sharply in 1968. An intensive publicity campaign launched in late July, and increased effort by Canada Manpower centres produced a positive effect. A record of student placements was maintained separately from other placements of a temporary nature from July 25 to September 11, 1968. During this period 13,131 students were placed in employment.

#### BOOKLET "CANADIAN OPPORTUNITIES-HOUSING"

### Question No. 688-Mr. Nesbitt:

Will the Minister of Manpower and Immigration inquire into a booklet published by his department and apparently distributed to prospective immigrants overseas, under the tile "Canadian Opportunities—Housing" in order to ascertain when the "Juliana Apartments" in Ottawa should have been singled out as a typical Canadian apartment dwelling and whether the owners are being charged for the free visual publicity provided by a fullpage colour photo?

Hon. Allan J. MacEachen (Minister of Manpower and Immigration): Yes. The building in question is not described as a typical Canadian apartment dwelling. Rather, in context with a variety of photographs in the pamphlet, it forms only one part of a pictorial description of the different varieties of accommodation available in Canada. None is described as "typical". The apartment building is not identified by its name or the city of its location, nor is this pamphlet distributed in Canada. Under these circumstances, therefore, it cannot be seen how the owners of the building are receiving free publicity.

## STATUE OF SIR CHARLES TUPPER ON PARLIAMENT HILL

## Question No. 704-Mr. Coates:

Is the government giving consideration to the erection of a statue of Sir Charles Tupper on Parliament Hill and, if so, when, and, if not, for what reason?

Hon. Gérard Pelletier (Secretary of State): The government does not have under consideration at this time extending the present sculpture project to include others who have at some time held the post of prime minister, including Sir Charles Tupper.
