to the Bowater case, which is the one my hon. friend has in mind at the moment, I must say that I have received no requests for assistance either from the company or from the Newfoundland government. However, my officials are in touch with both the government of Newfoundland and the company in London and have made their services available if the need arises.

**Mr. James A. McGrath (St. John's East):** As a supplementary question, Mr. Speaker, may I ask the minister if he intends to propose to his colleagues in the government the placing of a moratorium on further grants to new paper mills in Canada until world market conditions improve?

**Mr. Pepin:** Mr. Speaker, I think the problem is more complicated than the hon. member is implying at this time.

Mr. McGrath: You are building new mills.

**Mr. Pepin:** There are things called new mills which have the higher degree of productivity; there are things called older mills which have a lower degree of productivity, and there are things called multinational companies.

# INQUIRY AS TO DEBATE ON ABORTION
