WABUSH AIRPORT, LABRADOR

Question No. 1,918-Mr. Robinson:

- 1. Has any land been acquired or is any being acquired for the expansion of Wabush Airport in Labrador and, if so, how many acres?
- 2. How many acres of land are presently utilized by Wabush Airport?
- 3. Are the facilities at Wabush Airport to be increased for international air traffic stopovers?
- Mr. Gérard Duquet (Parliamentary Secretary to Minister of Transport): 1. Negotiations are currently underway between the Ministry of Transport and Wabush Iron Co. Limited for transfer to the Federal Crown of additional lands required for the longer term development and zoning protection of Wabush Airport. Actual acreage to be acquired has not yet been established.
- 2. Actual acreage required for all types of airport use still under negotiation (Question 1). However, runways, taxi-ways and apron (aircraft movement areas) comprise approximately 86 acres.
- 3. No. Facilities currently being expanded to serve domestic needs.

AIR CANADA—PROVISION OF SPECIAL SEATING AREAS FOR NON-SMOKERS

Question No. 1.934-Mr. Noble:

Has, or will, the government request Air Canada to provide separate seating areas on Air Canada planes for non-smokers?

Mr. Gérard Duquet (Parliamentary Secretary to Minister of Transport): On a voluntary basis in April 1971, when Air Canada introduced the Boeing 747 provisions were made for a cabin section (Cabin "D") to be designated for non-smokers. Also, on September 1, 1971, Air Canada introduced no-smoking areas on all types of aircraft which are at present in use on all routes.

In addition to University students, this classification includes Community College and Technical Institute students. The numbers of Post-Secondary students registered with Canada Manpower Centres for summer employment in the months of May, June, July and August for the year 1971, are: May, 71,061; June, 36,489; July, 22,391;

2. The number of confirmed placements of students in employment during May, June, July and August of 1971, was: High School Students: May, 1,768; June, 14,274; July, 25,061; August, 15,635. Post-Secondary Students: May, 21,737; June, 30,267; July, 16,484; August, 9,494. The number of students placed and the number not placed cannot be accurately determined because a large number of students do not report the results of their referrals to the Canada Manpower Centre.

PUBLIC SERVANTS—DISPLAY OF POLITICAL POSTERS ON PERSONAL PROPERTY

Question No. 1,971-Mr. Burton:

Are public servants prohibited from displaying or allowing to be displayed a political poster on their personal property and, if so, under what authority?

Hon. Gérard Pelletier (Secretary of State): I am informed by the Public Service Commission as follows: Section 32 of the Public Service Employment Act provides that: Public servants may attend political meetings and may contribute money for the funds of a candidate for election or money for the funds of a political party. In addition, an employee may seek nomination as a candidate and be a candidate for election in a federal, provincial or territorial election, provided he is granted leave of absence without pay by the Public Service Commission for such purpose. This section of the act, however, prohibits employees from engaging in any other type of work for, on behalf of or against a candidate for election or a political party.
